Asbestos Maintenance Worker Initial \$315

- Also known as Class III or O & M Training (Operations & Maintenance)
- Who Needs this Training?** Maintenance/custodial staff, electricians, HVAC technicians, plumbers, etc.), who may work in a building public or commercial, or a school that contains asbestos.
- In this 2-day course workers will cover regulations regarding this type of limited asbestos-related work, history, & uses of asbestos materials in buildings, potential health effects, personal protection, engineering controls & response actions, & methodologies for abatement & disturbance during routine maintenance activities.
